This tasteful residence has high ceilings and open floor plan with living, dining and kitchen on the first floor, and three bedrooms and two baths on the second. The living areas open to a covered, screened-in lanai equipped with a hot tub and added privacy from the preserve area in the back. The central kitchen has eat-in counter, extra space for a dinette and sliding glass doors to the outdoor area. The spacious master suite has a stepped ceiling, two walk-in closets and luxury ensuite bath with two vanities, deep soaking tub and walk-in shower. The second floor has a multi-purpose alcove that can be used as an office or common sitting area. This immaculate townhome has impact windows, shutters for the glass doors, tile roof and brick paver driveway and walkway.

Sonoma community amenities include an outdoor swimming pool, sports court and two playgrounds. Nearby conveniences include Publix, Detweiler's Farm Market, Jessica's Organic Farm, University Town Center, SRQ International Airport and Nathan Benderson Park.



  - 4.3 miles to Nathan Benderson Park
